PNGCS MEMBERSHIP QUALIFICATIONS

A person is qualified to be a member of the Society if the person is a natural person:

- (a) has been nominated for membership of the Society as provided by Rule 5; and
- (b) has been approved for membership of the Society by the committee of the Society.

4.1 Membership Category and qualifications

4.1.1 *Student Membership (SPNGCS)*

Student membership is available for those who are currently pursuing information technology course in a recognized institution.

4.1.2 *Provisional Associate (APNGCS Prov.)*

To be eligible for admission as a provisional Associate, a person must have completed a diploma level course in a recognized institute or university.

4.1.3 *Associate (APNGCS)*

To be eligible for admission as an Associate, a person must:

- (a) Have completed a diploma level course
- (b) Have at least 2 years practical experience in information technology field.

4.1.4 *Provisional Member (MPNGCS Prov.)*

To be eligible for admission as a provisional member, a person must have a bachelor's degree in information system or technology

4.1.5 *Member (MPNGCS)*

To be eligible for admission as a member, a person must:

- (a) Have completed a bachelor's degree in information system or technology
- (b) Have minimum two years practical experience in Information Technology
Or
be a full member of an overseas computer society

4.1.6 Fellow (FPNGCS)

To be eligible for admission as a fellow, a person must:

- (a) have a full membership
- (b) have minimum 10 years practical experience as a full member in information technology field.

Or

be a fellow member of an overseas computer society.

4.1.7 Honorary Fellow (FPNGCS)

To be eligible for admission as an honorary fellow, a person must:

- (a) be a well respected person by the business community
- (b) have made remarkable contribution towards Information Communication Technology development or education.
